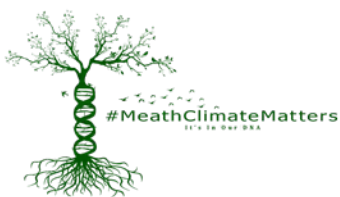
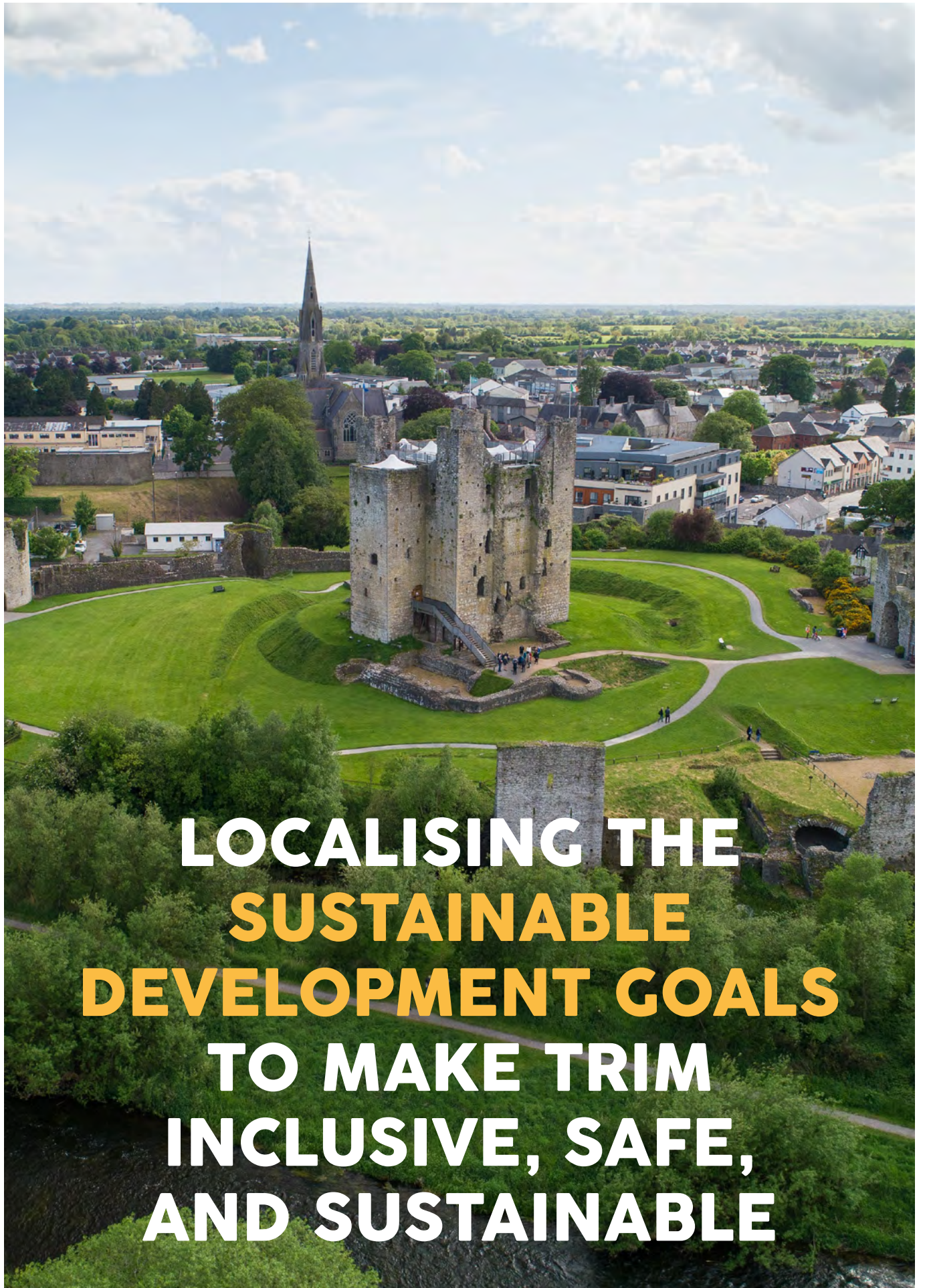

In September 2020, on the 5th anniversary of the Sustainable Development Goals (SDGs), Meath County Council committed to embedding the SDG goals into the organisation, work, and services and to be a leader in creating awareness and promoting the SDGs to the many citizens across the county.

Ireland's National Implementation Plan for the Sustainable Development Goals, 2022-2024 provides a whole-of-government approach to implement the 17 Sustainable Development Goals (SDGs). It is therefore fitting for Meath County Council to progress the SDG journey further by localising the SDGs through the creation of an Integrated Action Plan for Trim Town in collaboration with the URBACT Local Group.


FOREWORD FROM THE CHIEF EXECUTIVE OF MEATH COUNTY COUNCIL

PART ONE

SETTING THE SCENE

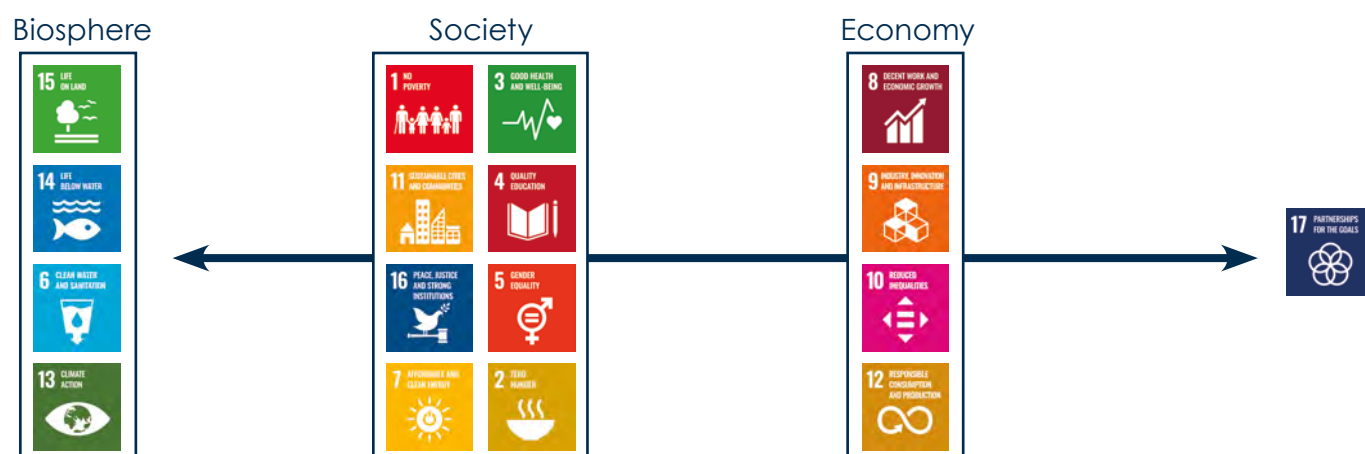
The 2030 Agenda for Sustainable Development, adopted by all United Nation Member States in 2015, provides a shared aim for partnership, peace, prosperity for people and the planet. The 17 Sustainable Development Goals (SDGs) integrate all three aspects of sustainable development; social, economic and environmental. They call for action by all countries - poor, rich and middle-income - to end poverty, fight inequality and stop climate change.

This Action Plan sets out a framework to localise Sustainable Development Goals within Trim Town. Using the URBACT Method, Meath County Council and local stakeholders have developed this Action Plan to integrate the 2030 Agenda in Trim town to translate the SDGs locally into policy planning supporting the design, implementation, monitoring and review of locally appropriate SDG actions.

“Localising the SDGs” is a growing, multi-faceted practice, which started taking shape in 2015 when cities were officially placed at the heart of the 2030 Agenda for Sustainable Development adopted by all 193 UN members states in 2015. While officially adopted by national governments, the need to involve local stakeholders have been recognised since the adoption of the 2030 Agenda.

When adopting the agenda, SDG 11: Make cities and human settlements inclusive, safe, resilient, and sustainable was singled out as its own distinct goal in a multi-lateral agreement. Localising the SDGs goes beyond SDG 11. Several international organisations have pointed out that many SDGs and targets – around 65% – will not be reached without the active involvement and contribution by local and regional governments (OECD, 2020). The SDGs hence apply to cities and municipalities as governments in their own right – and not only as “mere implementers” of a global agenda set elsewhere (UCLG, 2017).

This Action Plan will be the first locally developed plan in Meath that links actions that have been undertaken within the community of Trim to the sustainable development goals. While most of the actions undertaken by both the council and community fit into the SDGs framework, the attribution of how these actions contribute will provide a clear footprint of how this can be achieved in future plans.



1.1 LOCAL CONTEXT & POLICY CHALLENGES

1.1.1 Local Context

Trim introduction

Trim is a heritage town located within easy reach of the capital Dublin. It has over 5,000 years of history, with the famous Trim Castle dating back to the 12th century, which is well known from featuring in the popular film Braveheart.

Trim contains more medieval buildings than any town in Ireland. It is situated on the banks of the River Boyne in an area of fertile plains. The town developed around Trim Castle, straddling the river to the north and west of the castle. In the 13th century the town was enclosed within a circuit of stone walls. Augustinian (1202), Franciscan (1260), and Dominican (1263) friaries were established, indicating the growing prosperity of the town. In the later medieval period Trim became an increasingly exposed frontier, standing between the (sometimes) hostile worlds of the Anglo-Normans and the Gaelic Irish. Aside from Trim Castle, which dominates the town, the fragments of the medieval town are still clearly visible.

Demographic context

The 2016 census shows the population of Trim Town as 9194, with a population density of 1,587 people/km². It is projected that the population will increase by 12.68% between 2021 and 2027. 23.3% of population are in the age range of 0-14 years, 66.6% are in the age range of 15-64 years, and 10.2% are in the age range of 65 plus years.

Economic context

Trim is a self-sustaining growth town with a unique cultural and built heritage identified in the Regional Spatial and Economic Strategy (RSES) as a medieval heritage town. With a 'Jobs: Resident' Workforce ratio of 0.67 and 2,500 jobs in 2016, Trim is the second largest centre for employment in the County.

The sources of employment are varied with the top three employment sectors being commerce & trade, manufacturing industries and professional services.

There is a roughly even breakdown of persons at work between males and females with males accounting for 53% and females accounting for 47% of persons at work. The main sectors of employment for males are commerce & trade, manufacturing industries and building & construction. The main sectors of employment for females are professional services, commerce & trade and public administration. There is a countywide unemployment rate of 11%.

The vision going forward for Trim is to maximise the number of local job opportunities while investing and expanding in the tourist product in the town. Meath County Council's 'County Development Plan' supports the continued economic development of the town through the facilitation of the development of a live work community including a key piece of road infrastructure for the town. Trim is in a unique place to avail of both Urban Regeneration and Development Fund (URDF) (as a town of fewer than 10,000 people both with more than 2,500 jobs) which will present opportunities for funding going forward. Currently Trim Library and Cultural Centre is being developed to support Urban Regeneration and Development.

1.1.1 Local Context

Environmental context

County Meath is in the fertile agricultural land of the Boyne Valley, and the Municipal District of Trim, which is the administrative centre for the southwest of the county, is located on the Boyne river.

Recycling

Recycling is a key component of sustainable waste management and Trim is served by a recycling centre.

Flooding

Trim is predominantly at risk of fluvial flooding from the River Boyne, although the smaller watercourses are predicted to have some degree of risk.

Catchment Flood Risk Assessment & Management mapping have noted that significant flooding from the River Boyne in the centre of the town has been recorded for over 100 years. Flood forecasting and warning systems has been recommended for the Boyne River basin, comprising of gauging stations (existing and new) and a forecasting model system.



Transport

There have been significant improvements to the quality and frequency of bus services to and from the urban centres of County Meath to Dublin. Bus Éireann currently operates a commuter service from Trim Town to Dublin City and provides public transport services linking other population centres in the County such as Navan, Kilmessan and Dunshaughlin. In addition,

there has been an increased frequency of local bus services largely as a result of the establishment of Louth Meath Fingal Local Link. Louth Meath Fingal Local Link run a daily route between Trim and Navan to assist passengers who wish to access education, training, or employment.

Tree Planting

The Elder Project is an ambitious Trim Tidy Towns led project that aims to help plant over 10,000 native trees and shrubs in Trim and its environs, one for every member of Trim's population over the next 10 years. This project is being delivered through partnership with a number of different stakeholders including Meath County Council, landowners and residents' associations.

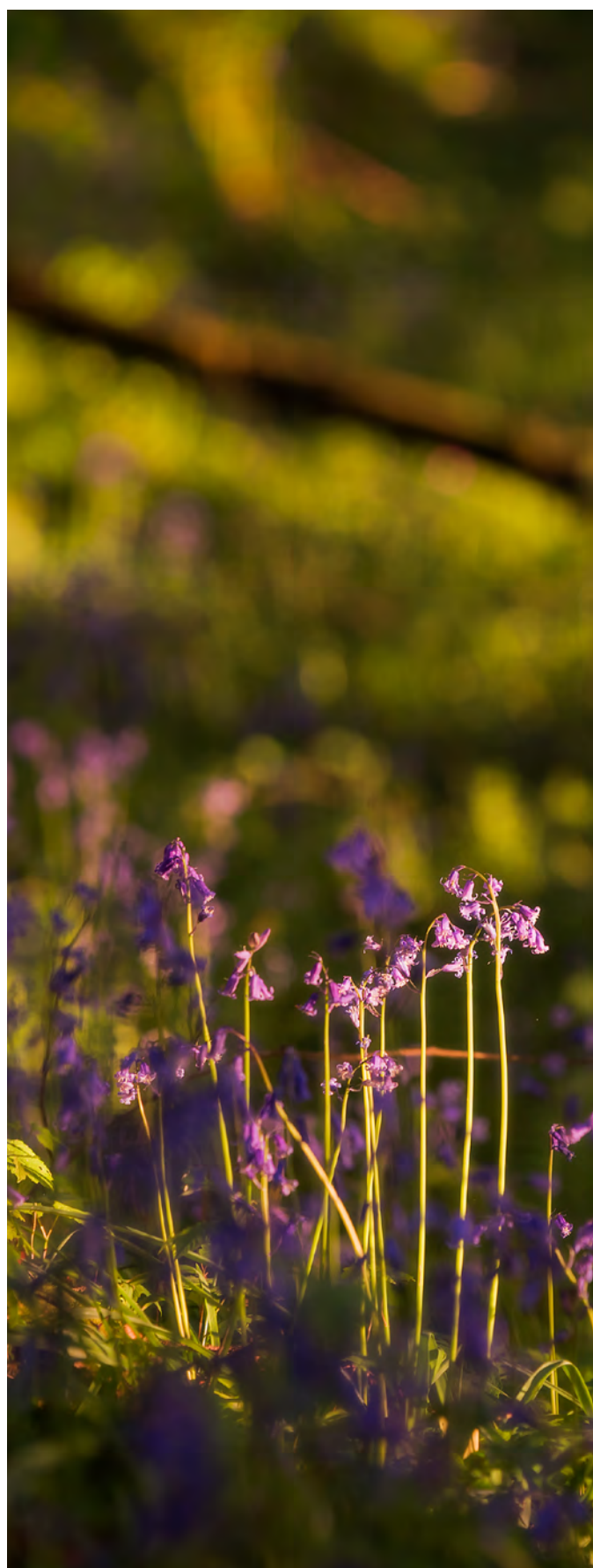
Trim

As different size towns and cities face different challenges and have different resources available to deal with these, a European Pilot Programme was established to assist with localizing the Goals. Following the announcement of Meath County Council's commitment to promote the Goals, the Council were asked to partake in this European Pilot Network project.

The heritage town of Trim was chosen as the pilot town to design an Integrated Action Plan on the localisation of the Sustainable Development Goals.

Using the URBACT Method, Meath County Council has developed this Action Plan to integrate the 2030 Agenda in Trim town in order to translate the SDGs locally into policy planning supporting the design, implementation, monitoring and review of locally-appropriate SDG actions.

The first work element and possibly the most important part of the project was the establishment of the Urbact Local Group (ULG), to establish a team who have both local knowledge of the town and the activities, opportunities and challenges within but who are also trusted by the community and are active within the community.



1.1.2. Analysis of the initial situation and policy challenges

Trim is the administrative centre for the southwest of County Meath. It is located 44km from Dublin City Centre and 14km from Navan Town (county town). Trim is located in the fertile agricultural land of the Boyne Valley, and the Municipal District of Trim, which is the administrative centre for the southwest of the county.

The 5 dimensions (P) of the 2030 Agenda consist of People, Prosperity, Planet, Peace and Partnership. The strengths and challenges for Trim can be analysed through the 5 Ps. The 5 Ps highlight how the SDGs are an intertwined framework as opposed to a group of individual goals. One way to address the strengths and challenges that exist within Trim, is to focus on the “5 Ps” that shape the SDGs:

People, Prosperity, Planet, Peace and Partnerships. Progress on one P must balance and support progress on another.

The Urbact Local Group utilised the Reference Framework for Sustainable Cities toolkit (RFSC toolkit) to identify and analyse areas of strength and challenges/weaknesses within Trim, for which the 5 Ps can assist in the development of the vision of the IAP.

People:

Strengths: Trim has a strong history of community engagement and volunteerism. An example of this is Trim's Community Sensory Garden which makes nature accessible to people of all abilities and promotes inclusivity. The project involved a number of partners and the community in its creation.

Challenges: The strength of community engagement and volunteerism will be key in the challenge to ensure no one living in Trim experiences:

Fuel Poverty, Food Poverty, Access to medical care, Lack of safe space for young people and Gender Inequality.

Prosperity:

Strengths: Innovative shops which promote sustainable products and zero waste demonstrate a gradual mindset shift towards what we buy and its impact on the planet.

Challenges: Increasing innovative and sustainable actions will be key in the challenge of ensuring that all in Trim can access:

Domestic retrofitting programmes, renewable energy, have access to employment opportunities, have access to free wi-fi and high internet speed and that all persons in Trim can enjoy inclusivity across the whole of community.

Planet:

Strengths: The beautiful River Boyne which runs through Trim and through County Meath. This river links us to our past and is a big part of our heritage and connects us to our place. We work hard to protect it for us and future generations to enjoy.

Challenges: Actions to protect our Planet within the environs of Trim require a multi-faceted approach which can be addressed through considering the following:

Focusing on water conservation and sustainability, supporting a circular economy, contributing towards climate action and actions to protect life below water and on land.

Peace:

Strengths: The local Garda station, where local Gardai ensured people stayed within their 5km during the Covid pandemic, are an essential part of Trim's community and have been involved in local charity initiatives.

Challenges: However, a key challenge will be to encourage partnership between the various institutions in Trim to pursue the SDG goals and to increase the level of citizen participation in public consultations.

Partnership:

Strengths: Partnerships such as our partnership with SEAI (Sustainable Energy Authority of Ireland) has facilitated frameworks to support Trim SEC (Sustainable Energy Community) to complete an EMP (Energy Master Plan). This benefits all by providing a road map to sustainable energy and to start a conversation to sustainable energy communities.

Challenges: Such partnerships benefit the whole community and the adoption of a local area plan and development of a wide range of community groups will continue to benefit the whole of Trim. The challenge now is to make action happen from these partnerships.

1.2 Focus on the Integrated Action Plan

1.2.1. The SDG Story and Missions

The Integrated Action Plan (IAP) for Trim will play an important role in raising awareness of the Sustainable Development Goals (SDGs). It will also provide a framework in which the SDGs can be localised not only in Trim but across the county. It will provide great insight into the best practice for involving the community to be part of the decision-making process, leading to a more holistic approach for delivering SDG related actions within towns.

The URBACT Local Group (ULG) have envisaged a future for Trim they would like to see, as an equitable, inclusive, climate friendly town. Through the visioning stage the ideas of all stakeholders involved were pooled together to create a future SDG driven story for Trim set in 2050.



Trim – A Place for the People



Trim is a town with a strong ethos of inclusivity and partnership, where diversity is respected, and global citizenship is welcomed. People work together to create inclusive, people orientated spaces. It is a place with a multitude of neighbourhood places where people can meet, make, play, eat, grow, share and reflect. A town that is people centric, not car centric. A place where all cultures and ethnicities feel welcomed. Hunger and poverty are not an issue and all men and women, in particular the poor and vulnerable have equal rights to economic resources. Full and productive employment and decent work for all men and women including young persons and people with disabilities and equal pay for all has been achieved in County Meath. Access to adequate, safe and affordable housing and basic services is ensured. Equal opportunity and reduced inequalities of income are achieved. Effective, accountable and inclusive institutions function at all levels and community and citizen participation is high.

Trim – A Safe, Equitable & Thriving Place to Live



Trim is a safe and peaceful place to live. Businesses are thriving and have become sustainable. Produce and products are locally sourced where possible. Every person in Trim has received education on sustainable development, inclusivity, diversity and on being an active global citizen. Education facilities that are child, disability and gender sensitive and provide a safe and inclusive learning environment for all are built or upgraded. Safe, affordable, accessible and sustainable transport systems are provided. Incidents of crime and violence have been reduced and people feel Trim is a safe town to live, and there is respect between all residents and tourists alike. Poverty has been eradicated from the town and sustainable economic growth has been achieved. A strong community ethos and openness in Trim has led to strong community engagement in the policies of the town and also international partnerships.

Trim – A Sustainable, Environmentally Friendly Town



Trim has transitioned to a fully decarbonised town run on renewable energy; energy that is affordable for all. The work of the Trim Sustainable Energy Community has pushed forward the retrofitting of houses within the town, and the energy master plan has seen the town becoming a leading centre for sustainable energy within Meath. Net zero Green House Gas emissions has been achieved. Capacity and knowledge on all aspects of climate change has been improved. The River Boyne maintains excellent water quality standards, the town and environs are litter and waste free and nurture biodiversity. The air is cleaner, biodiversity has increased. The town is quieter with less cars on the roads, and those that remain are fully electric. Active travel has been widely adopted throughout the town, improving the health and wellbeing of the residents.

1.2.2. Getting to the Focus of the IAP

The Reference Framework for Sustainable Cities (RFSC Tool) was the first step in the Urbact Local Groups journey towards identifying and prioritizing the ambitions of the Integrated Action Plan. The checklist of 25 questions within the framework allowed the group to prioritise the areas that the URBACT Local Group felt were important for incorporation within the Plan.

The next stage involved the URBACT Local Group developing the vision of the Integrated Action Plan. Assistance was provided by an external sustainability expert to help the group to translate the areas for action that were identified in the Reference Framework for Sustainable Cities into three specific visions for Trim Town which are:

- Place for the People
- A Sustainable, Environmentally Friendly Town and
- A Safe, Equitable & Thriving Place to Live

The facilitation session with the external sustainability expert also assisted the group in expanding on each vision to identify missions that would be pursued via specific objectives and actions.

Mission No. 1 aims to contribute towards making Trim a 'Place for the People' through working to ensure all citizens and residents of Trim will have equitable access to inclusive, biodiverse, public and community spaces by 2030.

Mission No.'s 2 & 3 aim to support Trim to become a 'Sustainable, Environmentally Friendly Town' by taking action so that people living in Trim will have access to effective, affordable and climate friendly public & active transport and that Trim will have reduced its energy usage as well as lessened its reliance on carbon-based energy by 2030.

Mission No. 4 aims to support Trim to be a safe, equitable and thriving place to live, by working to reduce inequalities in all aspects of life in Trim.

1.2.3. Defining the Missions, Specific Objectives & Actions

The URBACT method & tools are based on 3 core principles, Integration, Participation and Action Learning. This method was followed to define the missions, specific objectives and actions of the Integrated Action Plan.

Transnational Exchanges

Transnational exchanges took place between Trim and the network of 18 European cities who were also working to create Integrated Action Plans for their own cities. The Transnational exchanges allowed peer learning to occur, through direct communication and meetings which facilitated the exchange of knowledge, experience and good/best practices and assisted in guiding the creating of the Integrated Action Plan.



URBACT Tools

Collaboration – learning from other cities and exchanging best practices provided the opportunity to enhance skills and know-how and share lessons throughout Europe.

Integration: Following an integrated approach that considers and combines a number of different approaches such as vertical, horizontal and territorial cooperation and the balance between hard (infrastructure) and soft (human factor) investments.

Participation: Where the voices of all stakeholders are heard through citizen participation, co-creation and multi-level dialogue.

Action Learning: Where better knowledge and skills are acquired by working with peers, solving concrete problems by designing and testing tailor made actions. This includes planning, identifying resources and assigning actions to implementing and following up policies, evaluating the impact to feeding back the lessons learned.



PART TWO

By 2030, reduce inequalities in all aspects of life in Trim.

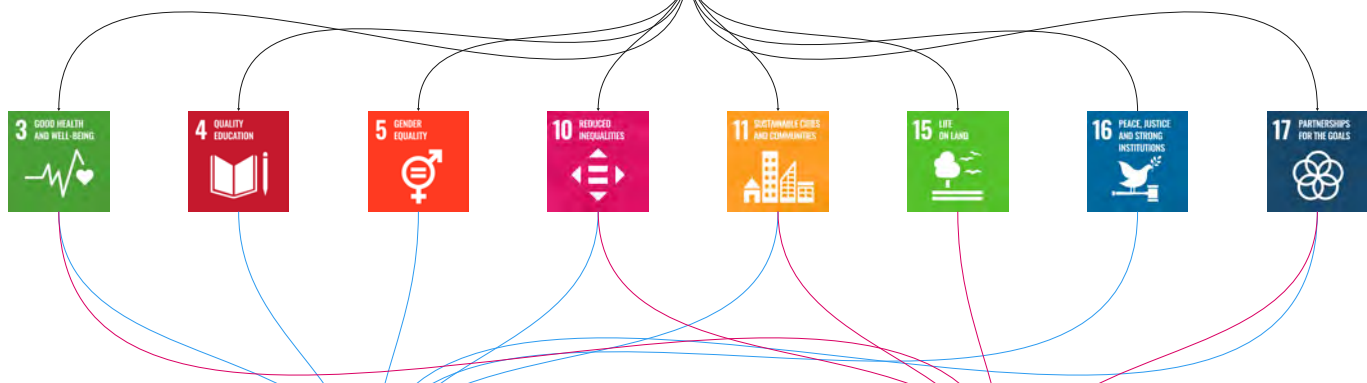

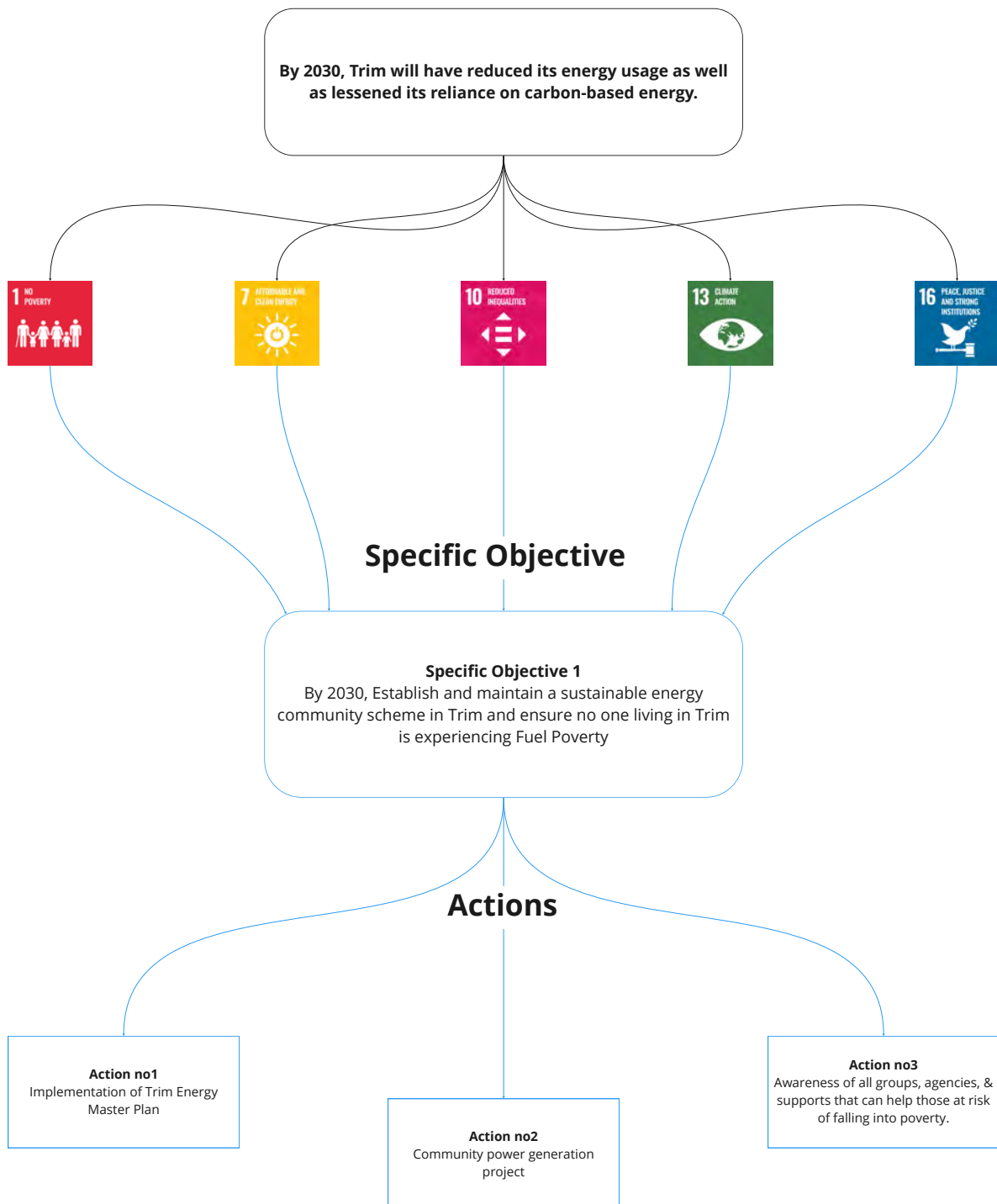

PART THREE

SETTING UP THE IAP FOR IMPLEMENTATION

3.1. Local Governance of the Action Plan (Framework for delivery)

Firstly, what is the purpose and mandate of the Trim participatory governance body?

It will provide a forum for exchange between diverse groups of actors. Help set priorities and give advice to the town's leadership on the systemic transformation of the town. Finally, the group propose innovative ways to get citizens/residents involved in decisions about new action and priorities.

The actors involved will cover a broad spectrum of Trim society:

- Citizens and Residents
- Local Government
- NGOs and Civil Society Groups
- Schools
- Cultural Institutions
- Councillors
- Youth Councils

In due course, it is desired to include individual experts, possibly universities to add a level of knowledge on the implementation and monitoring some of the actions present in the IAP.

Citizens will initially be appointed by targeted invitations from the local government, but later this will be expanded to open calls for expressions of interest. Trim has a population of just over 9000 inhabitants and no more than 11/12 participants will be required within the group. Each organisation/stakeholder group will have 1 seat with a substitute if the first member cannot make a particular meeting/event.

This governance body will be a citizen's assembly that feeds into local government and will be hosted by Meath County Council, chaired by a member of the advisory group. It will meet quarterly (this can be reviewed at a later date). It will make decisions based on consensus but will have no formal decision-making authority.

There will be several key outputs that the governance body produces. These will include:

- New actions for the town's transformation
- Proposals for engaging citizens and local residents
- Monitoring and evaluation reports
- Expert opinions on technical topics (down the line)
- Scientific assessments and advice (down the line)

3.2. Resources and funding

How do you go from 'action planning' to implementation?

This is possibly the greatest challenge facing any 'action planning network' partner, the transition from action planning to implementation. Firstly, each action within this Integrated Action Plan identifies potential funding streams, and secondly, actions with funding streams will be explored through the action. It is not within the scope of this plan to identify guaranteed funding streams for each action. If an identified funding stream is not suitable additional new/ existing funding streams can be explored.

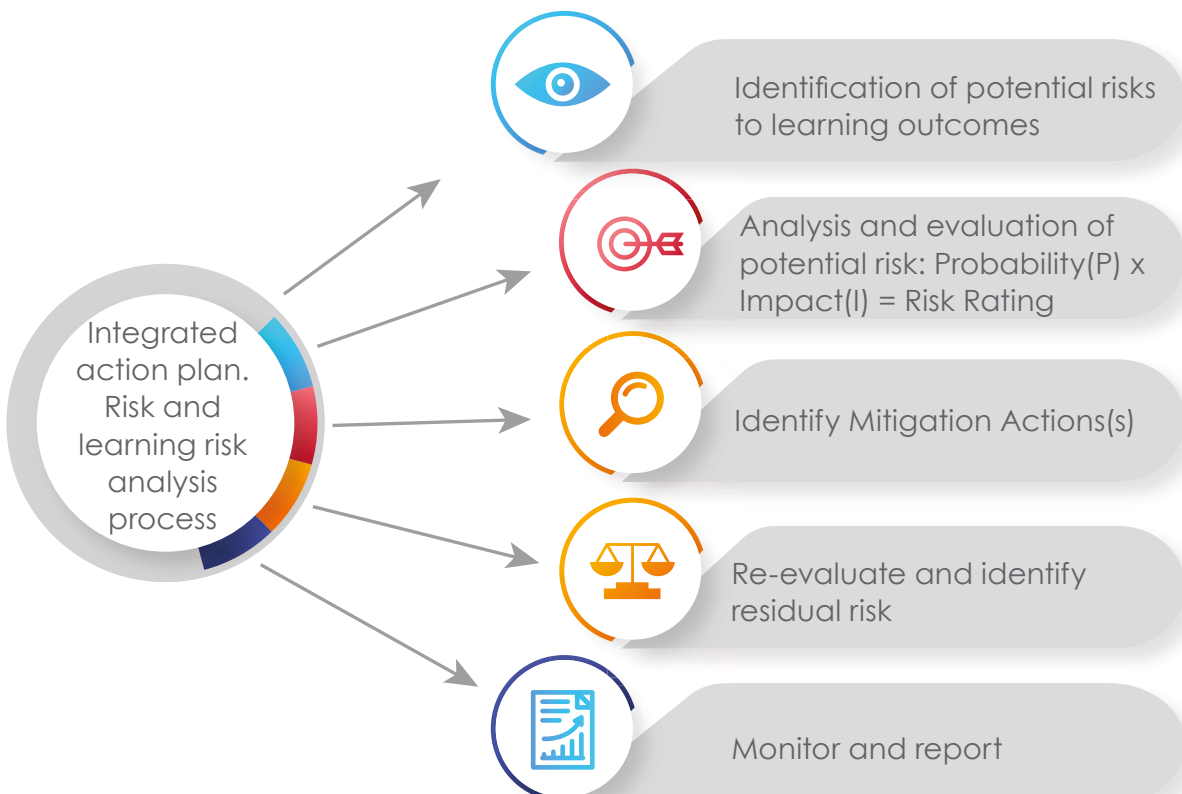
Funding streams range from local funding all the way to European level funding, including, but not limited to, municipal budgets, community grants, national funding (e.g. Community Climate Action Fund) and European funding (e.g. ELENA - European Local Energy Assistance).

It will be the requirement of each lead actor of an action to identify other resources required (e.g. staff) or whether the action may be funded with their regular budget.

3.3 Risk and Learning Analysis

Managing risk and learning outcomes requires judgements and informed decisions in order for the intended outcomes to be met. The ULG has undertaken a risk and learning analysis on actions identified within this Integrated Action Plan. This will allow for risk and intended learning outcomes to be met. The analysis methodology, matrix and risk register is detailed below.

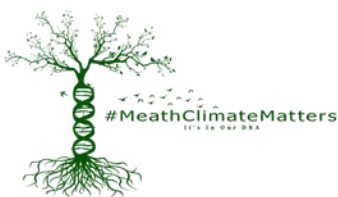
