Introduction

Section 35 of An Garda Síochána Act 2005 provides for the establishment of Joint Policing Committees (JPC). The Meath Joint Policing Committee was established in 2015 and new guidelines for Joint Policing Committees were issued by the Policing Authority in 2022.

Role of the Joint Policing Committee

The Purpose of the Joint Policing Committee (JPC):

Section 36 of the Garda Síochána Act 2005 (the Act) provides for the establishment of a JPC in each Local Authority administrative area. The purpose of a JPC is to provide a forum where a Local Authority and Senior Gardaí, responsible for policing the area, along with Oireachtas Members and community interests can consult, discuss and make recommendations on matters affecting the policing of the area to contribute to the improved safety and quality of life of the community.

Strategic Approach: In accordance with national JPC guidelines the focus of the JPC's work is "strategic" rather than "operational". The JPC is required to develop a six-year Strategic Plan linked appropriately with the Local and Economic Community Plan for the area. Meath JPC adopted its new Strategic Work Plan 2021–2026 in February 2022.

Steering Committee

The Meath JPC Steering Committee consists of the chairperson of the JPC, a representative of An Garda Síochána and the Chief Executive of the local authority or a person nominated by him or her. The function of the steering group is to facilitate the efficient functioning of the JPC and in particular to ensure that it retains a clear focus on strategic and collaborative action. It will also arrange procedures for the appointment of any new or replacement members, draw up the agenda and arrange documentation for meetings, be the point of contact for co-operation and joint action with other JPCs and with any subcommittees of the JPC.



Summary of progress in implementing the JPC's work programme

The JPC strategic plan 2021 – 2026 provides a structured and integrated approach to achieving social, economic and environmental wellbeing of all those that work, live and visit county Meath.

In this strategy three strands inform the work of the JPC, namely educational/awareness work, prevention and enforcement. The strategy outlines general aims, so that the JPC can be flexible to adapt to changing priorities and good practice over the term of the Plan.

The priority issues for the County Meath JPC have been identified as the following and these are consistent with the current Local Economic and Community Plan and Age Friendly Strategies that have been adopted by the Council.

- Crime Prevention to reduce the levels of crime in County Meath
- Community/Personal Safety— to increase people's sense of security in their communities and ensure that they can undertake their daily activities in a safe manner
- Promoting Public Order to reduce the incidents of anti-social behaviour and public disorder in County Meath
- Road Safety to reduce road accidents and fatalities







Garda Report & New Garda Síochána Operating Model

At each of the Joint Policing Committee meetings throughout 2023, the Chief Superintendent presented a report to the members of Meath JPC, setting out the detailed quarterly crime statistics for the Meath Divisions including:

- Burglary
- Property Crime
- Theft
- Robbery
- Assaults
- Traffic Collisions
- Sexual Offences
- Public Order Offences
- Drugs Summary
- Policing Demand
- Arrests & Searches
- Crime Patrolling and Checkpoints
- Review of Traffic Policing

The Chief Superintendent highlighted many issues including key crime statistics, resources available to the Gardai, emerging trends and patterns of crime, public order, anti-social behaviour and the misuse of alcohol and drugs.

Members of the JPC regularly highlighted areas of local concern and issues raised were dealt with by the Chief Superintendent and his team of Superintendents.

At the December meeting, the Chief Superintendent gave a presentation to the JPC on the New Garda Síochána operating Mode in the Meath/Westmeath Division that became operational in November 2023. The new Operating Model came about as a result of the Commission on the Future of Policing in Ireland. Under the new Meath/Westmeath Divisional Structure, the Divisional Headquarters is located in Athlumney House, Navan. There are a number of Functional Areas within the new Division: Community Engagement, Crime, Performance Assurance and Business Services. Each Functional Area is led by a Superintendent, with the exception of the Business Services Functional Area which is being led by an Assistant Principal.

The former Districts and District Headquarters have been replaced by Community Engagement Functional Areas.

Meath has 2 Community Engagement (CE) Functional Areas spanning the Division, namely:

- Meath North CE Area, Headquarters Navan, headed by Superintendent Martina Noonan
- Meath South CE Area, Headquarters Ashbourne, headed by Superintendent Yvonne Murphy

The remaining functional areas are:

- Performance Assurance
- Crime
- Business Services







An Garda Síochána is changing in order to provide a greater focus on community policing based on local needs consistent with the objective of "Keeping People Safe".



Engagement with the Community - JPC Public Meeting

A public meeting was held on the 21st September 2023 in Village Hotel, Bettystown, Co Meath.

In advance, and in line with the guidelines, members of the public were invited to submit their views in the form of questions on general policing matters affecting the policing of County Meath. A total of 8 written questions were received in advance and a number of other questions were taken during the meeting, all of which were responded to by Chief Superintendent Dollard and his team and revolved around community policing, levels of crime, road traffic issues. The following items were discussed:

- Antisocial Behaviour in the East Meath Area including Scrambler Gangs and Antisocial Behaviour in Navan Town Centre including complaints and concerns from Navan Retailers
- The need for visible policing in East Meath and Navan Town to address increasing Antisocial Behaviour
- Garda Resources and
- Speeding and requests for traffic calming measures
- The enforcement of parking regulations and illegal parking and the reporting process
- The refurbishment of Laytown Garda Station
- Community Policing
- The Text Alert Scheme
