The Chief Executive introduced the report and noted that it was a reflection of the tremendous amount of work done in accordance with the core objectives as set out in the Corporate Plan. He acknowledged the support of the Councillors, the Management Team and the Staff in the delivery of services.





There were interventions from **Councillors Gillian Toole** and **Aisling Dempsey. Councillor Gillian Toole** raised concerns regarding the volume of paperwork submitted with the agenda. **Councillor Dempsey** acknowledged that sufficient time had been given to peruse the documents.

The Annual Report was adopted on the proposal of **Councillor Maria Murphy** and seconded by **Councillor Sarah Reilly**.

5.1.3 To note the 2023 MD Allocation Scheme Annual Report.

The report was noted by the Elected Members

5.2 Planning

5.2.1 To consider the Chief Executive's Report in accordance with Section 13(4)(a) of the Planning & Development Act, as amended, on submissions to <u>Proposed Variation No. 1</u> to the Meath County Development Plan 2021 – 2027, and to consider making, not making or modifying the Proposed Variation.

The Chief Executive introduced the item noting that the core aims of the Council were to deliver housing in the County and to drive economic development.

There were interventions and queries from Councillors Nick Killian; David Gilroy; Gillian Toole; Paddy Meade; Gerry O'Connor and Joe Bonner. Queries raised included clarification on the process and requirements to declare conflicts of interest. Responses to queries raised were provided by the Council's Law Agent, Rory McEntee and the Chief Executive. It was noted that it is the responsibility of each Elected Member to declare any potential conflict in accordance with Part 15 of the Local Government Act, 2001 (as amended) and the Code of Conduct for Councillors.

Mr Alan Russell, Senior Executive Planner, gave an overview of the details of the proposed Variation No. 1 to the Meath County Development Plan 2021 – 2027, including legislative requirements under Section 13 of the Planning and Development Act 2000 (as amended). He further noted that the purpose of the Chief Executive's Report is to report on the outcome of the consultation process on the proposed variation, set out the Chief Executive's reponse to the issues raised in the submissions and to make a recommendation on the proposed amendments, as appropriate.

There were interventions and queries from Councillors Ronan Moore; Brian Fitzgerald; Elaine McGinty; Maria Murphy; Nick Killian; Gillian Toole; Michael Gallagher; Sean Drew and Trevor Golden. Matters raised included details of housing figures in the Core Strategy, difficulties with census figures, requirement to have social infrastructure in tandem with construction, impacts of previous judicial reviews, implications of proposals to review County Development Plans every ten years, settlement capacity audit, water and waste water capacity in Kells. Responses to queries raised were provided by the Senior Planner, Padraig Maguire and the Chief Executive. It was noted





that Uisce Eireann had assured the Council that there was sufficient capacity for water and waste water in Kells and that further details would be circulated to the Elected Members.

The Elected Members resolved, on the proposal of **Councillor Alan Tobin**, seconded by **Councillor Gerry O'Connor** and unanimously agreed by all the Elected Members present, to make Variation No. 1 to the Meath County Development Plan 2021 – 2027, as recommended by the Chief Executive.

5.2.2 To consider the Chief Executive's Report in accordance with Section 13(4)(a) of the Planning & Development Act, as amended, on submissions to <u>Proposed Variation No. 2</u> to the Meath County Development Plan 2021 – 2027, and to consider making, not making or modifying the Proposed Variation.

Mr Alan Russell, Senior Executive Planner, gave an overview of the details of the proposed Variation No. 2 to the Meath County Development Plan 2021 – 2027, including legislative requirements under Section 13 of the Planning and Development Act 2000 (as amended). It was noted that the proposed variations had been discussed with the Elected Members at various Council Meetings in October, November and December 2023 and January 2024. It was agreed that each element of the variation would be discussed separately.

tourism potential in other parts of the County. Responses to queries raised were provided by Mr. Padraig Maguire, Senior Planner and Mr. Alan Russell.

Proposed Amendment (g): Ratoath Land Use Zoning Map (Ratoath Outer Relief Road)

Councillor Nick Killian declared a potential conflict of interest due to his constituency office landlord being the owner of the lands that are subject to the proposed variation. Councillor Killian left the room.

The following Councillors expressed concerns in relation to the proposed amendment:

Councillors Gerry O'Connor; Brian Fitzgerald; Maria Murphy; Joe Bonner and Gillian Toole.

There were queries from Councillors Aisling Dempsey; Alan Tobin; Alan Lawes; Paddy Meade and Eugene Cassidy. Queries raised included the layout of the proposed road, the potential to use the CPO process to acquire the lands, previous planning decisions by An Bord Pleanala and potential effects on other zoned lands. Responses to queries raised were provided by Mr.

Padraig Maguire, Mr. Martin Murray and the Chief Executive. The Chief Executive noted that the use of the CPO to acquire the lands is not the preferred option as the objective, as set out in the County Development Plan, could be achieved by the agreement of the landowners associated with this variation.

Councillor Nick Killian returned to the room.

Proposed Amendment (h): Ratoath Land Use Zoning Map (Town Centre)

Councillor Nick Killian expressed his support for the proposal. Noted by the Elected Members.

Proposed Amendment (i): Athboy Land Use Zoning Map

The following Councillors expressed concern regarding the proposed variation: **Councillors Paddy Meade, Joe Bonner, Amanda Smith,** and **Elaine McGinty**. Further clarification was provided by Mr. Padraig Maguire.

It was proposed by **Councillor Sean Drew** and seconded by **Councillor Padraig Fitzsimons** to make the variation no. 2 as recommended by the Chief Executive. A further proposal to make the variation with a modification to remove proposed amendment (g): Ratoath Land Use Zoning Map (Ratoath Outer Relief Road) was proposed by **Councillor Gerry O'Connor** and seconded by **Councillor Brian Fitzgerald.** It was proposed by **Councillor Paddy Meade** and seconded by **Councillor Gillian Toole** to make a modification to remove proposed amendment (k): Map 8.1 Brú na Bóinne World Heritage Site map update in Volume 3 of the Meath County Development Plan 2021 – 2027.

The meeting was adjourned for 10 minutes.

Following the resumption of the meeting, the Meeting Administrator advised that, in accordance with the standing orders, each proposed modification would be dealt with separately, with the first proposed modification being dealt with first.

Councillors Aisling Dempsey and **Nick Killian** left the room due to potential conflicts of interest as outlined previously.

The Meetings Administrator noted that there were no further modifications to consider. It was noted that the Elected Members had resolved to make Variation No. 2 to the Meath County Development Plan 2021 – 2027, with a modification to remove proposed amendment (g): Ratoath Land Use Zoning Map (Ratoath Outer Relief Road).





5.2.3 To receive the Chief Executive's Report in accordance with Section 37E(4) of the Planning and Development Acts, in relation to a Strategic Infrastructure Development application made to An Bord Pleanála, reference ABP-319448-24, for proposed development of 8 no. wind turbines and associated works at Galboystown, Co. Meath and Clonmellon, Kilrush Upper, Kilrush Lower, Newtown, Ballinlig, Carnybrogan, Cavestown and Rosmead County Westmeath.

An Cathaoirleach Councillor Tommy Reilly left the meeting and the Leas-Chathaoirleach, Councillor Paul McCabe presided in his absence.

Ms. Teresa O'Reilly, Executive Planner, provided a broad overview of the proposed strategic infrastructure development application. She outlined details of the application, including the site location, haul route and the key considerations contained in the Chief Executive's Report. The Elected Members were advised that they could raise matters at the Council Meeting and that detailed submissions could be made to the Meetings Administrator by email and these submissions would be included in the CE Report.

There were interventions and queries from the following Elected Members:

Councillor Sarah Reilly noted that she had liaised with local residents in relation to the proposal, and concerns were raised in relation to a lack of public consultation, the location in the River Boyne and Blackwater SAC, protected structures within the proximity of the proposed development and impact on the natural environment.

Councillor Gillian Toole commented on the end of life of turbine blades, compliance with Circular Economy legislation, and compliance with planning conditions.

Councillor Joe Bonner queried details on the duration of the community fund and how the funds would be allocated.

Councillor Michael Gallagher queried who would be responsible for monitoring noise within proximity of the proposed development.

Responses to queries raised were provided by Ms. Teresa O'Reilly.

5.2.4 To receive a presentation on the Meath County Council Economic Development Strategic Action Plan.

Mr. Des Foley, Director of Services provided a broad overview of the Strategic Action Plan. He outlined details of the Vision as well as the six overarching actions contained in the Plan. He further outlined the vision and actions for each workstream of the Economic Devleopment Forum.





There were interventions of support and queries from Councillors Joe Fox; Ronan Moore; Alan Tobin; Joe Bonner' Sean Drew; Gillian Toole; Sharon Tolan; Maria Murphy; Yemi Adenuga; Emer Tóibín; Padraig Fitzsimons; Trevor Golden; Brian Fitzgerald and Gerry O'Connor. The Elected Members broadly welcomed the Plan and noted the opportunities available both nationally and internationally to further promote Meath as the Place and Space to Thrive. The Chief Executive thanked the Members for their positive support and further noted the marketing opportunities for Meath in terms of arts, culture and tourism.

5.3 Finance

On a proposal from **Councillor Sharon Tolan** and seconded by **Councillor Joe Fox** it was agreed to take a 15-minute extension to 6.15pm.

5.3.1 To receive the Draft Annual Financial Statement 2023. (separate attachment)

Ms. Sheila Harkin provided an overview of the details of the Draft Annual Financial Statement 2023. She outlined the analysis of revenue income and expenditure and noted a cumulative general reserve surplus of €276,273 at the end of 2023. In addition, the value of the total fixed assets reflected in the balance sheet at 31st Dec 2023 of €3.046bn was noted.

An Cathaoirleach, Councillor Tommy Reilly returned to the meeting and presided over the remainder of the meeting.

There were interventions from **Councillors Brian Fitzgerald**, **Gerry O'Connor**, **Sean Drew** and **Gillian Toole**. The improvements in the Council's finances were noted.

Of the households with children, 58 families are placed in short term private rented accommodation (house/apartment) through Settlement Team's intervention and 9 Families in PMVT Family Hubs.

Reasons for emergency accommodation placement in order of frequency: Primary reason is family breakdown; relationship breakdown; unable to a find property to rent; Notice to Quit; domestic violence; overcrowding; couch surfing; addiction; mental health; house fire; unsuitable accommodation; rough sleeping.

The HAP shared services centre in Limerick City and County is responsible for HAP payments. The information has been requested from Limerick City and County Council and we will circulate the information to the Elected Members when the information is available.

"Can Meath County Council provide details of the number of planning applications received in the last 5 years for childcare facilities and the numbers that have been granted, refused or pending. Can this be broken down by MD?

Response:

Meath County Council's Planning Department does not have data on the number of planning applications for childcare facilities received in the last 5 years or the numbers that have been granted, refused or pending, as this information is not currently extracted from applications for all non-residential development.





However, in an effort to assist with this question, as part of Forward Planning's ongoing Development Plan Monitoring, the number of childcare facilities that have been granted permission since the coming into effect of the County Development Plan on 6th November 2021 is collated. The Social Infrastructure Tracker shows that 12 childcare facilities have been granted since 6th November 2021. The breakdown per Municipal District is as follows;

Navan – 3
Laytown/Bettystown – 1
Ashbourne – 2
Ratoath – 1
Trim – 2
Kells – 3

The Forward Planning team has also recently commenced Social Infrastructure Audits for Navan, South Drogheda and Maynooth Environs which will detail the total number of childcare facilities in each settlement, capacity available and the future childcare requirements. The Social Infrastructure Audits will inform the Local Area Plan for Navan and the Joint Local Area Plans for Drogheda and Maynooth.

This has a number of key objectives relating to Social Infrastructure specifically for vital community amenities such as creches, playgrounds, retail spaces or shops to ensure that each Municipal District is sufficiently served with these facilities

9.1 Submitted by Councillor Elaine McGinty (Deferred from April meeting)

"To ask Meath County Council to consider the introduction of columbarium walls in the cemeteries under its management."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The Council initiated a tender process for the procurement of suitably qualified Contractors for the development of Columbarium Walls and Urn Plots in The Good Shepard Cemetery Duleek, St Declan's Ashbourne, St Finian's Navan, Derrockstown Dunshaughlin and Rooske Cemetery Dunboyne. A contract has now been signed in respect of these works and it is expected the contractor will commence the works, starting in Duleek around the second week of May .

The Columbarium Walls in each Cemetery will be developed to accommodate 80 niches over two blocks- one block has already been developed as part of the extension to Rooke Cemetery. The development of the plots in the four cemeteries will accommodate circa 900 urn burials .

The Meetings Administrator noted that she had received correspondence from **Councillor Elaine McGinty** withdrawing the Motion.

9.2 Submitted by Councillor David Gilroy

"I propose that Meath County Council Transportation Section develops a comprehensive assessment framework to gauge the social impact of new infrastructure in rural communities, taking into account factors such as enhanced community interaction, road safety, accessibility to essential services, and the promotion of local identity and belonging.

If this motion is approved, it will be forwarded to the Transportation SPC for review. The Transportation SPC will consider it in the context of the draft policy on "Footpath Amenity Scheme for Community and Sporting Facilities in Rural Areas," which is currently being developed by the SPC.

"I call on the Minister to Meath County Council to allocate all resources necessary for the recruitment of additional planning staff, recognising the pressing need to efficiently deliver on planning requirements, under NPF, RSES and CDP and ensure effective management of development projects in our county now and into the future."

Resourcing is an issue not only for Meath's Planning Department, but all Local Authorities across the country. In a recent review of the department by the Office of the Planning Regulator, their draft report has cautioned that the resourcing of the department must be an ongoing priority for Meath County Council. Unfortunately, due to a shortage of experienced, qualified people in the sector, the filling of posts at the various grades, is posing very difficult. To counteract this, Meath County Council is running a rolling competition for Executive Planners and creating a number of Graduate Planner positions to assist with all the functions, projects and caseloads that the department is managing, including those mentioned in the motion.

The motion, together with supporting documentation was agreed on the proposal of **Councillor David Gilroy**, seconded by **Councillor Trevor Golden** and unanimously agreed by the Elected Members.

9.4 Submitted by Councillor Emer Tóibín, Councillor Alan Lawes and Councillor Gillian Toole

"To call on Meath County Council to build, buy or adapt a building to provide emergency accommodation for homeless people in the form of a homeless hostel in Meath.

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The Housing Department is actively exploring possibilities to buy and adapt a building or to purpose build a Short Term Accommodation Facility (STA). However any proposals for an STA in the County would be subject to the approval of the Regional Homeless Forum and the Department of Housing, Local Government & Heritage.





The motion, together with supporting documentation was agreed on the proposal of **Councillor Emer Tóibín**, seconded by **Councillor Alan Lawes** and unanimously agreed by the Elected Members.

9.5 Submitted by Councillor Paddy Meade

"Meath County Council will endeavour to register a legal right of way with Land Registry Ireland on all required Land Portfolios and Maps to provide a legal right of way to the entrance point of each Council owned graveyard in County Meath, so that council workers and members of the public can visit and maintain graves year-round."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

The Public Health (Ireland) Act of 1878 is the historic legislation which vested control of Cemeteries in the Sanitary Authorities (now County Councils) and such vesting includes both the Cemeteries themselves and all easements in and out of the properties. There are long established easements of access which do not have to be registered in the Land Registry and in the rare occasion where issues as to access arise, they are usually resolved on the ground with the landowner. In some cases, there may be agreed alternative routes and in such circumstances a Grant of Easement is obtained and registered in the Land Registry.

The motion, together with supporting documentation was agreed on the proposal of **Councillor Paddy Meade**, seconded by **Councillor Michael Gallagher** and unanimously agreed by the Elected Members.

9.6 Submitted by Councillor Paddy Meade

"Meath County Council will request a copy of each Graveyard Register in County Meath from the appointed Registrar or Caretaker this year 2024, and once again every 5 years into the future."

<u>Supporting Information subject to the motion being proposed, seconded and considered.</u>

Meath County Council carried out an extensive survey of all 231 burial grounds in the County in 2012/2013 and arising from which a register was created and containing inter alia the following information:

- Ownership / Vesting details and if registered in the Land Registry
- Status of the burial ground whether open, dormant (family plots) or closed
- Potential capacity remaining and options for extension
- Year of opening and most recent burial





Caretaking and contact person for the burial ground.

The information contained in the register serves to provide very valuable information both for the Council in terms of planning for replacement burial grounds or extensions, as well as responding to regular requests from members of the public who are involved in Genealogical Research or trying to contact parish or community groups who manage the burial grounds.

While the register is updated as new information comes to hand for individual burial grounds, it is acknowledged there is a need to update the complete register, and this will be undertaken as resources permit.

The motion, together with supporting documentation was agreed on the proposal of **Councillor Paddy Meade**, seconded by **Councillor Alan Lawes** and unanimously agreed by the Elected Members.

9.7 Submitted by Councillor Michael Gallagher

"That Meath County Council in conjunction with the Department of Transport, source funding and put a plan in place to restore the local roads in the County to the required standard."

Meath County Council, supported and funded by the Department of Transport, delivers a substantial planned annual roadworks programme throughout the county on the regional and local road network. The Transportation Section is in regular communication with the Department of Transport's Inspector and should any additional funding become available Meath County Council has iterated willingness to discharge this funding to the roadworks programme, the delivery of the roadworks programme under 4 separate contracts builds flexibility to deliver additional works.
