Launch of Water Action Plan 2024

The Water Action Plan 2024 was launched by Minister of State Malcom Noonan TD on the 4TH September 2024 and representing Irelands third River Basin Management Plan. The plan is Ireland's roadmap to protect and restore our rivers, lakes, estuaries, coastal waters and groundwaters and seeks to have an additional 300 waterbodies achieve "good" status by 2027 with targeted measures to improve 500 more.

Air Quality -Solid Fuel Regulations

Effective from 31st October 2022, new regulations were introduced to improve air quality and public health by banning the sale of bituminous (smoky) coal, wet wood, and turf (with limited exceptions). These fuels are known for their high smoke emissions, which are linked to poor health outcomes.

The Council is initiating an awareness campaign in respect of violations of the Regulations and specifically the sale of smoky coal and asking members of the public to report such activity to the Environment Section.

Composting and Recycling for Schools

Twenty Meath Schools have signed up for the comprehensive 'Composting and Recycling for schools' programme with Craig Benton and the Clean Technology Centre for 2024.

The aim of the programme is to help schools prevent waste, improve recycling and set up, start or improve on-site composting systems to reduce waste, save money and combat climate change. The programme also helps schools improve their gardening efforts and increase biodiversity around their schools. All of these activities assist schools with attaining their Green School Flags and reaching their Sustainable Development Goals. In addition, the programme gives teachers access to a wide variety fun, participatory and interactive activities for school children to learn about waste prevention, recycling, composting and gardening. These activities support children's understanding of the underlying principles of ecology, biology and biodiversity that underpin all life on our planet.





Leaf Mould Pilot Project

Each year, resident associations wonder what to do with all of those autumn leaves. This year Meath County Council has introduced a pilot project across 10 estates in Navan, Ashbourne and Dunboyne, assisting residents to make a lovely weed-free compost for use within their community. With the appropriate training and resources — leaf cages, rakes, etc, they will turn their leaves into a resource, that will enhance their gardening in the future. Ten groups have been selected for this year's pilot project which begins in October.



Green Schools Seminar

Meath County Council will co-host a seminar for all Meath wishing to take part in Green Schools Programme in October. The online event, for teachers, parents and caretakers, will provide workshops on each of the Green Schools Themes – Litter and Waste, Energy, Water, Biodiversity, Travel, Global Citizenship. Participants will get an overview of each them, and step by step

suggestions, as to how they can implement the programme in their schools. The secondary school seminars begin in September with Primary and others taking place in October.

Energy Audits

In line with our decarbonisation strategy for Meath County Council's buildings, Energy Audits have been undertaken and reports completed for four buildings. The audits analyse the current and future energy uses in the buildings, while also proposing solutions to increase the energy efficiency and decarbonise the buildings. The measures identified for upgrading in each building will contribute to our programme of upgrade works for 2025 and help continue progress to the public sector 2030 targets for CO₂ emission reductions.

An application for the construction of 22 new residential units comprising 6 no. two-bed, single storey units, 6 no. two-bed, two-storey houses & 10 no. three-bed, two-storey houses at Archdeaconry Glebe, Kells, was lodged with An Bord Pleanála on the 22nd of November 2022 and was approved by the Bord on the 1st of February 2024.

The matter is now subject to Judicial Review brought by Kells Anglers Association and Ciaran O'Kelly -v- An Bord Pleanála and Uisce Éireann, and Meath County Council (Notice Party) High Court No 2024 440 JR. The matter was listed for mention in the High Court in the Planning and Environment List on Monday 13 May 2024 and then hearing is expected to be scheduled for December/January.

*Carrick Street, Kells

An application for the construction of 36 new residential units, and refurbishment of 9 existing derelict units to provide 11 new units, giving a total of 47 residential units in Carrick Street in Kells was lodged with An Bord Pleanála on the 29th of July 2022 and was approved by the Bord on the 12th of February 2024.

The matter is now subject to Judicial Review brought by Kells Anglers Association and Ciaran O'Kelly -v- An Bord Pleanála and Uisce Éireann, and Meath County Council (Notice Party) High Court No 2024 484 JR. The matter was listed for mention in the High Court in the Planning and Environment List on Monday 13 May 2024 and then hearing is expected to be scheduled for December/January.

Affordable Housing

The 2023 allocation of 70 houses for Affordable Housing Delivery are all finalised. This consisted of 10 no. 2-bed houses, 57 no. 3-bed houses, and 3 no. 4-bed houses – giving a total of 203 bedrooms to date housing 179 people in the 70 confirmed purchased properties. All the units were constructed to an "A" energy rating.

One 3 bed property for affordable purchase in Rowleys Lock, Navan has been allocated.

A scheme of 6 houses 3nr. 3 bed duplexes and 3nr. 2 bed duplexes closed for applications 19th September 2024 and was oversubscribed.

Expressions of Interest

The Housing Department continue to collaborate with Developers and Landowners to purchase land and or properties for the provision of social and affordable housing.

Refurbishment Projects

St. Francis Park Scheme

The site consists of 10nr. residential units. The site has been fully snag inspected. Some snags and landscaping works remain to be closed out. It is expected the Scheme will be substantially complete in September 2024.

Alverno Court Refurbishment:

Certificate for Substantial Completion for the final Phase 5 (6nr. units) was issued on 22nd August 2024.

Local Authority Adaptive Work Scheme (LAWWS)

- LAAWS grant funding of €563,533 including VAT submitted for approval to DHLGH for 2024.
- To date for 2024, 58nr. LAAWS are complete and another 16nr. LAAWS are appointed to Contractors.
- This brings the total to 74nr. LAAWS applications scheduled to be completed in 2024.

During September, the LAIT Support Workers continued the yearly progression and conducted 11 on-site clinics at IP (international protection) and Ukrainian centres throughout Meath.

These clinics facilitated with the assistance of centre management addressed issues for new arrivals in such areas of education & training (23% of all referrals), accommodation queries (15%), employment (14%), health (11%), community engagement (11%) and transport (9%) with childcare youth support and general living/social welfare questions comprising the bulk of the remainder.

All referral matters were handled by the stakeholders of the Community Integration Forum.

Libraries Services



My Open Library Trim

Following a successful trial period of *My Open Library*, Trim library is now offering this service to users following an induction session. The new *My Open Library* service means that registered My Open Library users will be able to access Trim Library from 8am to 10pm, 7 days a week.

National Public Libraries Open Day

National Public Libraries Open Day promotes the role of public libraries in Irish society and raises awareness of the broad range of services provided. The Day is taking place on Saturday, 28th September, with 300+ libraries across Ireland marking it through activities, events and celebrations.

To mark the Day, Meath library staff will be delivering outreach eServices roadshows in Trim and Bettystown. Staff will demonstrate the array of services, beyond the borrowing of books, that are part of the library membership benefits, including eAudiobooks, eBooks, eMagazines, online courses and online language learning. All libraries will host a free STEAM Saturday event. This will be a great opportunity for parents and children to build, learn and play together using specially selected toys and games with a focus on creativity and imagination through Science, Technology, Engineering, Arts and Maths. The spotlight event for the National Public Libraries Open Day is the visit of The BFG to Navan and Trim Libraries.

People are encouraged to visit their local library for National Public Libraries Open Day and join the 784,000 people, equating to around one in six of the population, who enjoy the benefits of library membership.

The archives were involved in three events for Heritage Week in August 2024. Economic Development

The following is an update on some of the actions from the Meath Economic Development Forum Action Plan:

- Works are progressing well on the County Meath Centre of Business Excellence in Navan
- Work is continuing with a number of Meath Businesses in a pilot programme that will see them graduate to Enterprise Ireland and potentially scale their business through exporting.

Details of the trade delegation to Toronto, Canada in October are being finalised, with meetings scheduled with the Consulate General of Ireland, the IDA and Enterprise Ireland, as well as Tourism Ireland. To support the visits, work is continuing on developing an FDI Guide to Meath highlighting our connectivity and competitive advantages.

A comprehensive Business Supports Pack outlining the range of services, training and supports available is currently being finalised for small and medium local businesses. A digital version will then follow.

Food Development

Work is progressing on the programme of actions outlined in the new Boyne Valley Food Development Strategy 2024 – 2028. Two local food masterclass workshops took place during September, one on line and one in Lismullen Cookery School.

A review of the Discover Boyne Valley Flavours brand is underway to ensure that the messaging is effective for engagement with customers, stakeholders and members of the network. The final report should be available by the start of Quarter 4.

Boyne Valley Tourism Strategy 2024 - 2030

The new joint Tourism Strategy will be completed and launched on October 4th at a breakfast Launch at Emerald Park. The new strategy sets out an ambitious target to become One of the Leading Experiential Destinations in the World. With 7 strategic objectives and 6 key transformational Projects, this strategy will lead the Boyne Valley destination forward into a new era of tourism development signifying its movement into the international recognition.

Feile Siamsa Glas at the Boyne Valley to Lakelands Greenway

Féile Siamsa Glas took place over the weekend of 14th **and 15**th **September**. The festival celebrated the Boyne Valley's recently launched Greenway, combined with an opportunity to experience the unique Irish language and culture of Meath's Gaeltacht Baile Ghib. The purpose of the festival is to spread the economic benefit of tourism to the North Meath economy.

The festival included events at 5 villages along the Greenway. The flagship event was the Outdoor Immersive Theatre piece 'The Journey' at Wilkinstown Platform, where approximately 500 people participated over both days. The festival also included printing workshops, Toraíocht Taisce /Treasure Hunts at Kilmainhamwood, meditation, children's events and music at Wilkinstown, ceilí, biodiversity walks and sports for families at Baile Ghib and ceol agus craic at Castletown and Oristown. A key feature of the festival was to experience the Greenway where the Bodhrán Biking took place. The festival closed with the Cultural Concert in Nobber.

Oris Funding

The announcement of Oris funding for the Boyne valley to Lakelands Greenway in June will form part of a huge investment in Outdoor Adventure Tourism in Meath. This will include provision of information panels, benches and planting as well as creation of a website with comprehensive visitor information.

Spire of Lloyd Guided Tours

The pilot project of guided tours of the Spire of Lloyd will come to a close on September 27th. There are additional tours being scheduled for October 30th and 31st at 2pm, 2.45pm and 3.30pm which will be themed on Spirits of Meath Halloween Festival.

Meath Business and Tourism Awards

Sponsored by Meath County Council and Boyne valley Tourism, the Meath Business and Tourism Awards is a celebration of the successes of local businesses across County Meath. The deadline for nominations for the awards for 2024 was 20th September with a shortlist due to be announced soon who will go forward to present their business at the Pitch night. The Awards night will take place on Friday 8th November at Knightsbrook Hotel. We wish all participants every success with their nominations.

Púca Local Launch

The Púca Local Launch will take place at the Swift Theatre on Wednesday 2nd October from 6pm with Tom Dunne as MC and performances from Jennifer Leahy, Meath harpist and a spectacular performance from Broken Theatre. Meath County Council Cathaoirleach Cllr. Sharon Tolan and Chief Executive Kieran Kehoe will both speak at the event along with Fáilte Ireland as key stakeholders.

Other Information:

Increased Cost of Business (ICOB) Grant Scheme

The payment of ICOB grants is now substantially complete with 99% of valid applications now processed. The Department of Trade and Enterprise have advised that the scheme will close on Friday 27th September 2024. Rates staff are liaising with customers on the outstanding information required to process their grant application.

A total of €7.4m has been paid in grant funding to over 2600 commercial customers. €2.6 of this funding was paid to 1477 customers in the retail and hospitality sectors who received the second ICOB grant payment.
