## Air Quality Bulletin December 2024

The daily limit for  $PM_{10}$  is 50  $\mu g/m^3$ . The limit is deemed breached if more than 35 exceedances occur during the year. The hourly limit for  $NO_2$  is 200  $\mu g/m^3$ . The limit is deemed breached if more than 18 exceedances occur during the year. The table below shows the number of exceedances in 2024 to 31/12/24. This data is provisional and subject to future revision following any further data validation.
