Gillian Mangan Executive Engineer, Transportation updated the members on the proposed traffic calming measures. Interventions included.

- How many estates in Kells are taken in charge now that don't fall within the 30K speed limit.
- When will the next review of the 30k speed limit take place?
- Can clarification be sought on whether Housing Estates like Cross Carrick that have through roads are subject to the bye laws of 30k or 50k.

Gillian noted the above and will draft a response to the meetings administrator before the next Kells MD meeting.

4.1.2 To receive a Progress Report on works undertaken/planned for Kells Municipal District.

The report circulated in advance was noted. Interventions included:

- Can salt gritting bins be extended for use outside more schools in the area?
- Great work and response to the cold snap in early January 2025

Further to the progress report, all members raised concerns regarding a possible reduction of staff or resources for the outdoor crew for the MD that included:

- What changes if any have been made and will they begin?
- Staffing and machines are limited currently without making further reductions.
- Should resources not have been reviewed at our budget meeting in November 2024?
- Kells is the biggest road network in the County. Can we be kept abreast of how these efficiencies will improve things?
- Can a letter be written to the Chief Executive on behalf of the MD out lining the concerns above?

Dara McGowan, Director, replied to the members that the process of the review has not yet been completed and movement of resources is nothing new in the council. Talks are ongoing and any outcomes from the process will be to improve efficiencies in this area. Dara also reminded members that this is an executive function rather than a reserved function.
