Gaeltacht Scholarships

Meath County Council announced details of its Gaeltacht Scholarship Scheme for the 2025 year on the 14th January on council social media, the website, the Meath Chronicle, and the new newspaper 'An Páipéar' (directed at the Irish language speaking community). This scheme is open to students attending secondary schools in the County. Information regarding the scheme was forwarded to all secondary schools in the county also.

Twenty-four Máire Nic Shiubhlaigh grants of €150.00 each will be made available to students attending second level schools in the county. Eight Mother Columba Gibbons grants of €300.00 each will be made available to students attending DEIS second-level schools; and a further 6 Máire Ní Raghallaigh grants of €300.00 each will also be made available to students attending DEIS second-level schools. The grants will be recoupable against fees paid at recognised residential Irish colleges during the summer of 2024.

The Gaeltacht Scholarship Scheme is supported by the Meath County Council, Irish Language and Creative Ireland programmes.

Local Lens Podcast

Meath County Council's podcast series of six 30-minute episodes landed on Tuesday, February 25th. Local Lens meets the people involved in delivering over 1,000 services to over 220,000 people across the county and hears from people who use them. East Meath Civic Centre Opening



Storm Éowyn


During Storm Éowyn, the Communications team continually engaged with the public and provided updates across our social media platforms informing stakeholders as crews were mobilised to clear

Affordable Housing

Meath County Council will have a new affordable housing scheme for 10 units in Wellfield, Ratoath, Co Meath opening for applications soon.

Expressions of Interest

The Housing Department continue to collaborate with Developers and Landowners to purchase land and or properties for the provision of social and affordable housing.

Local Authority Adaptive Work Scheme (LAWWS)

- LAAWS grant funding of €614,789.19 including VAT was submitted for approval to DHLGH on 23rd January 2025.
- This includes 50 disabled persons grant units for €412,289.19 and 3 disabled persons grant extension units for €202,500.00.
- This brings the total to 53nr. LAAWS applications scheduled to be completed in 2025.

Housing Adaptation Grant Schemes for Older People and People with a Disability

214 applications for the value of €1,442,139.43 were approved in 2025.

Local Authority Energy Efficiency Retrofit Programme (EERP)

Energy upgrade works are currently ongoing on 20 properties.

Local Authority Planned Maintenance

Meath County Council (supported by DHLGH and the LGMA) is transitioning to a strategic and informed planned maintenance approach towards local authority stock through the completion of stock condition surveys. The ambition is to have surveys carried out on all local authority stock and to complete this work over the next 4 to 5 years. The software for carrying out these surveys was rolled out from the LGMA to Meath County Council late last year. 102 Stock Condition Surveys were completed in 2025, up to 18th February.

Pathfinder Scheme R161, Navan to Trim Scheme	In August 2024, Meath County Council wrote to the Minister of Transport to request that separate and specific funding be allocated for Meath County Council's Pathfinder Project on the R161 Navan − Trim Road. This correspondence was sent following discussions between MCC and the NTA regarding the AT funding likely to be available in 2024 and 2025. MCC advised the Minister that their understanding was that there was funding separate to the NTA ATIG for Pathfinder Schemes. MCC stressed that R161 Pathfinder Scheme was progressing well and on programme, however, the NTA had made it clear to MCC that the funding likely to be available in 2024/2025 and beyond would fall well short of what MCC require to keep its Active Travel programme on schedule. On the 8th November 2024, the Minister replied to our correspondence. He acknowledged the national situation and the fact that there are a large number of projects in the pipeline for delivery around the country in the years ahead. He advised that the demand for funding for active travel necessitated the need for project prioritisation, whereby funding will be allocated to areas of greatest impact. He also advised that he had no involvement with the selection of projects to be funded through the NTA's Active Travel Programme, and that MCC should continue to liaise with the NTA in the context of future funding allocations. MCC subsequently discussed its priorities with the NTA in the context of the funding likely to be available in 2025 and the other projects it is progressing. Regretfully, MCC is not in a position to progress this pathfinder scheme to the construction phase in 2025. An allocation of €50,000 has been provided by the NTA to bring the scheme to a suitable point and thereafter work will be suspended.

Boyne Greenway Navan to Oldbridge	Since the public consultation on the Emerging Preferred Route of the Boyne Greenway Navan to Oldbridge in early 2024, the project team have been developing the preliminary design of the Boyne Greenway route. To this end, various specific flora and fauna surveys have been completed as well as technical investigations such as a topographical survey has been completed and ground investigations are due to commence imminently. The Council is liaising with landowners regarding access for the ground investigation contractor and compensation for the proposed boreholes and trial pits on their lands.

Given the many factors at play, the design of and planning application for the Boyne Greenway presents significant substantial and unique challenges. The complexity of the scheme was again highlighted during the Appropriate Assessment process and the preparation of the Natura Impact Statement for the ground investigation works and ensuing engagement with the NPWS. We also note the recent refusal by An Bord Pleanala of the Blessington Greenway and the reasons underpinning their decision. The preparation of the planning submission to An Bord Pleanala will need careful consideration and take account both of the environmental and appropriate assessments as well as recent planning decisions. It is currently anticipated that the design and planning application for the Boyne Greenway will take circa 18 months to complete.

At the end of the route options assessment, the decision was made to de-couple the Navigation Restoration from the Greenway. This was done for a number of reasons including the availability of a funding source and the absence of a competent authority with the relevant expertise to develop the scheme and operate it in the long term. Meath County Council remains committed to assessing the viability of the restoration of the Boyne Navigation and is engaging with Waterways Ireland to establish whether or not the project would align with their strategic objectives.

Mid East Regional Enterprise Plan

Regional Enterprise Plans are created by local stakeholders and aim to collaborate on initiatives that promote enterprise growth. The Regional Programme Manager was appointed in November 2024, with Meath designated as the lead county in the region. Key priorities have included:

- Reviewing and recruiting new members for the Steering Committee, engaging key stakeholders
- Developing and scheduling a Regional Workshop to focus on priorities for the next 12 months
- Currently reviewing the existing Regional Enterprise Plan for DETE and initiating the consultation process for the new plan, which is set to launch in Q1 2026.

The first Mid East Regional Enterprise Plan Workshop took place at MaynoothWorks. This marked the first face-to-face meeting of key stakeholders. During the workshop, participants agreed on the key priorities for the current plan, identified potential working groups, and discussed the upcoming review process.

It was agreed that the selection of objectives for the next plan would commence in Q1 2025.

The Centre of Food Culture, Boyne Valley

The Boyne Valley Transition Year Young Cooks competition took place on Thursday 23rd January in Lismullin Cookery School with 9 schools taking part – 5 from Meath and 4 from Louth. 1 school from Meath and 1 school from Louth will now proceed to the National Final, joining teams from Monaghan, Cavan, Galway and Tipperary. Over the course of two hours, the talented young chefs prepared two courses, each highlighting at least two ingredients sourced from Boyne Valley producers. The winning team from Meath was Eureka Secondary School, Kells and the winning team from Louth was Sacred Heart Secondary School, Drogheda.

EVAC Committee

The first meeting of the 2025 Local Enterprise Office Evaluation and Approvals Committee met on Tuesday 11th February. Three companies had applied for grant funding and all were approved.

- Two Feasibility grants of €15,000 each were awarded.
 - One grant was to explore the commercialisation of a bespoke professional building project managements software package. The software was developed in house and the company wish to explore its applicability to the wider industry.

- The second grant was awarded to a start-up company exploring the need for an FMCG (fast moving consumer goods) purchasing network to work as a link between FMCG buyers and supermarket chains
- One priming Grant of €50,000 was awarded to a company providing high technology, precision filling systems for the liquid pharmaceutical manufacturing industry.

Community Development





Local Coordination Group established in response to Storm Éowyn

In the wake of Storm Éowyn, the Meath Local Coordination Group Chaired by Chief Executive Kieran Kehoe was activated in order to provide assistance to the worst affected areas of Meath.



The forum comprised of both internal and external key stakeholders who all provided support and assistance to those most in need. Community Hubs were established county-wide to provide humanitarian support as homes remained without electricity and water. An out of hours support phone line was manned each evening and early morning to provide additional support and direct people to the nearest relevant source of aid and the meath.ie website was updated regularly with the latest information available.

The coordination group met daily until power supplies were restored across the county.

Membership of the forum consisted of Meath County Council, An Garda Siochana, HSE, Department of Social Protection, LMETB, Meath Civil Defence, Meath Partnership, Meath Volunteer Centre, Meath GAA, IFA, Meath LCDC, Meath County Childcare Committee Local Link and Tusla.

Public Participation Network

- Meath PPN is confirmed as hosts for the 2025 National PPN Conference. This will take place in the Knightsbrook Hotel, Trim on October 16th & 17th, where 200 delegates from across the country will be welcomed to celebrate community engagement, showcasing best practice from Meath based groups. The theme for the conference will be "Building Better Communities", reflecting the constant striving towards building a strong network for volunteers, social prescribers and stakeholders.
- 734 groups are registered with Meath PPN.
- The Midlands Region PPN meeting was held in Bellinter House on February 5th with 26 representatives attending from the 6 PPNs. Topics discussed included funding, staff retention and the national coordination structure.
- Two sold out workshops on grant writing and fundraising were held on February 11th and 13th with 80 participants. Training on governance for community groups will be held in March.
- A grants calendar has been issued to all registered groups with information on annual grants and funding available throughout the year. The calendar is also available on PPN website: https://www.meathppn.ie/wp-content/uploads/2025/01/Grants-Funding-Calendar.pdf
- Meath PPN supported the Local Coordination Group liaise with community hubs, centers and sports facilities who were providing assistance following Storm Éowyn.

The consultation was advertised through the PPN, Meath County Council website, social media channels and the Meath Chronicle. The public consultation closed on 26th February.

Mapping Community Meeting Spaces Survey

The Community Department is conducting a survey to understand the needs of community groups for community meeting spaces. The aim of the survey is to understand what works well, the challenges facing community groups and to develop plans and policies to ensure everyone has access to appropriate community meetings spaces.

The survey will also be advertised through the PPN, Meath County Council website, social media channels and the Meath Chronicle.

The Survey will close on the 7th of March at 5pm.

Local Community Development Committee (LCDC)

The LCDC meeting scheduled for 24th January was cancelled due to Storm Éowyn and was postponed to 28th February 2025. This meeting will be held in person in the Deerpark Community Hub, Carlanstown, Kells to support the launch of the CommUnity Connect Project. The March LCDC meeting is due to take place on 28th March 2025.

LEADER Programme 2023 – 2027 – Local Action Group (LAG)

The last LAG meeting was held on 13th December and the next meeting of the LAG is scheduled for 28th February 2024, following the LCDC February meeting in the Deerpark Community Hub, Carlanstown, Kells.

Healthy Meath

Storm Éowyn caused the cancellation of the CommUnity Connects Launch planned for Deerpark Community Hub in Carlanstown at the end of January. This event has now been rescheduled to 28th February at same location to coincide with the LCDC meeting.

Comhairle na nÓg

The 2024 Annual Report and Expenditure Report for funds received from the Comhairle na nÓg Development Fund in 2024 is currently being completed for return to Pobal by 28th February 2025.

Local Enhancement Programme 2025

URBACT In4Green

The In4Green network aims to empower and build the capacity of local actors in industrial areas to overcome the barriers that prevent the transition to greener economies while remaining competitive and inclusive. The overall challenge that the In4Green network wants to address is the green transition in small and medium-sized European cities with an industrial past.

Meath County Council is progressing with the development of an Integrated Action Plan for Navan. The IAP is being developed through an integrated and participative approach. A local committee called the URBACT Local Group is helping form the actions for the plan. The group is made up of representatives from local Industry, local communities and representatives from Meath County Council, Cllr. Edward Fennessy is chair to the ULG. Sections 1 & 2 of the plan have been drafted and

we are now at the "preparing implementation" stage of the programme. The final plan is due to be launched by December 2025.

Woodland Creation on Public Lands

Funding has been approved by the Department of Agriculture Food and the Marine through the Woodland Creation on Public Lands Scheme for woodland which will be planted on 7.2 hectares of Meath County Council owned lands at Liscarton and at 3 hectares at Galtrim Lodge during Quarter 1 of 2025.

The purpose of the Woodland Creation on Public Lands Scheme is to encourage Public Bodies to establish new native woodlands on suitable bare land. This aim is consistent with the Programme for Government, which sought to "Embark on an ambitious programme of afforestation on state-owned lands".


Meath County Council's Climate Action Plan (CAP) Implementation Report for Elected Members and Stakeholders: This is the first report based on the 2024-2029 CAP. It will be made available at the March Full Council meeting.

Energy

Annual SEAI Monitoring and Reporting (M&R) Return

The Monitoring and Reporting system is a web-based software system through which public bodies and schools report energy, emissions and related data to SEAI each year. This enables SEAI to track each organisation's progress towards energy and climate policy targets. Each year, an annual report is generated to Meath County Council to track our progress towards 2030 targets. The M&R return involves the submission of large quantities of data from many sources, and this was completed by Meath County Council in late November. Below shows the current tracking against the target glidepath.



Green Schools

Meath Schools are currently undergoing Green School Assessments and Renewal Visits for the prestigious Green Flag Programme.

This comprehensive school action initiative addresses a range of environmental issues, including Litter and Waste, Energy, Water, Travel, Biodiversity, Global Citizenship, Marine Conservation, Food Production, and Sustainability. Students also engage in projects on Fast Fashion, Citizen Journalism, Activism, and more.

This annual competition is a collaborative effort between An Taisce Green Schools, Local Authorities, and Schools, forming part of the global UNESCO Environmental Education Scheme. The county boasts many outstanding examples of Green Schools, with Dunshaughlin Community College being a prime example. Their students presented an impressive showcase of their work during their assessment in February and eagerly anticipate receiving their first Green Flag in May.

Among their numerous innovative and effective actions, the students launched a successful Re-Turn Scheme to raise funds for redesigning their library, featuring a dedicated environmental and ecology education section.

3D Printing Workshop in Navan Library

Meath County Council Library Service purchased 3D Printers for Ashbourne, Bettystown, Navan and Trim Libraries in 2024. They will be used to deliver workshops as part of the library's annual STEAM programme and will also be made available to members of the public who wish to print their own printables.

Several staff members participated in two half-day training workshops in November 2024. Following this training, staff in Navan library delivered a Family Workshop in December for *Family Time at your Library*. The team then devised a four-week series of workshops for children and teens aged 10+. The aim of the programme is to introduce participants to the basics of 3D design software and printing. Staff will lead participants through three different design projects using TinkerCard, an online design platform. They will also learn the basics of preparing a design for print. The final workshop will offer each child the chance to put their skills into practice and plan and print their own design.

There has been great demand for this series of workshops and a waiting list of interested parties has been compiled for future sessions.

Ireland Reads Day on Saturday February 22nd.

Ireland Reads, a Government of Ireland initiative and funded by Healthy Ireland, encourages everyone to get lost in a good book. Studies have shown the mental health benefits that reading brings along with stress reduction.

- The spotlight event takes place in Trim Library where author Donal Ryan, the An Post Book of the Year Award winner, is in interview with author Nicola Cassidy.
- Each library will host story and craft stations on the day.
- Libraries will invite local class groups in the week leading up to Ireland Reads day.
- Author and illustrator, Tatyana Feeney, will be showcasing her new book, *Stockingopolis*, to invited junior/senior infant classes in both Trim and Oldcastle Libraries.
- An online Bookface competition will encourage the public to be creative and have fun with book covers where they merge themselves with the cover to create a fun optical illusion.
 This competition is open to adults, teenagers and children with a book token prize for each category winner.

Nobber Library

Nobber Library has reopened with extended opening hours making it easier for everyone to enjoy all the library has to offer. The introduction of a late night on Tuesdays will allow people who are working during the day better access to the library. In addition to its wide range of reading materials, the library offers free WiFi, public computers, a self-service printing, photocopying and scanning facility, a Magic Table for individuals with dementia and autism, study spaces and much more.

Creative Ireland - Lullaby Leaf

Lullaby Leaf is a captivating, fun-filled, and immersive, sensory theatre experience created by Ceol Connected for young children with complex additional needs and their guardian/carer. This 2024/2025 project was produced in association with Meath, Cavan and Monaghan County Councils.

As part of the Lullaby Leaf project, Ceol Connected designed and facilitated a series of CPD workshops which took place in all three counties in 2024. Tailored to the needs of artists and educators interested in learning skills and gaining experience in sensory arts for children with complex needs, this professional development initiative was delivered in the Swift Cultural Centre, Trim in June 2024.

In January 2025, Ceol Connected engaged a range of young students with severe and/or complex special educational needs in the delivery of multiple Lullaby Leaf performances in the Swift Cultural Centre, Trim from January 13th to January 17th. A talented team of artists from the fields of music, dance, visual arts, theatre and circus facilitated children on a sensory journey where they experienced what it is like to live on a giant leaf.

The project culminated in a Lullaby Leaf Symposium at Íontas Theatre in Castleblayney, Monaghan, on Friday, 24th January
